OENOBOIS® GRANULAR FR (French oak granular) **FRESH, LIGHT, MEDIUM**

FORMULATION

French oak granular from selected species *Quercus robur* and *Quercus sessiliflora*, sourced only from French forests. These forests are naturally grown without any treatment products. Woods are naturally air- seasoned 24 months minimum before transformation. No chemicals are used during the stage of transformation or storage. Once seasoned, oak is machined to transform into granulars, then toasted with a convection oven to reach the define temperature: FRESH, LIGHT, MEDIUM.

FIELD OF APPLICATION

Use on white, rosés and red wines, during fermentation steps.

Enological product, whose utilization is controlled according to the regulation. Refer the legislation in force in your area.

APPLICATION RATE

White and rosés wines: 0.5 to 2 g/L. Red wines: 1 to 4 g/L. Application rate must be adapted to the organoleptic objective.

DIRECTIONS FOR USE

Use by soaking the oak granular in the grape or must.
